What is an EHF?

Environmental Handling Fees (EHFs) are charged on the sale and distribution of all new electronic products regulated in British Columbia and reflect the costs to responsibly recycle these products.

The items listed below can be dropped off free of charge at any authorized Recycle My Electronics collection site.
