Join the Recycle Beverage Carton Art Contest (the "Contest") for a chance to win a CAD \$100 gift card. The Contest begins on March 1, 2023 at 8:00am PT and ends on March 31, 2023, at 11:59pm PT and is open to BC residents of who have reached the legal age of majority. To participate:

- create an original drawing that (i) incorporates the idea of "push the straws in" or "keep the
  caps on" when recycling beverage cartons and (ii) features an artwork character representing a
  recyclable beverage carton, wherein the artwork character may be or be based on a Return-It
  Gang character, such as OJ Carton and Joyce Box, and the recyclable beverage carton may be for
  juice, milk, or plant-based beverage;
- share the drawing on Facebook, Instagram, and/or Twitter along with a message that (i) tags or mentions RecycleCartonsCA and Return-It and (ii) includes the hashtag #RecycleBeverageCartons.

Twenty (20) entrants will be selected by random draw and each such selected entrant will receive a CAD \$100 gift card. No purchase necessary. Full rules follow below.

# Recycle Beverage Carton Art Contest Official Rules

## 1. What Is the Recycle Beverage Carton Art Contest About?

The Recycle Beverage Carton Art Contest (the "Contest") aims to encourage community recycling and promote recycling awareness. The Contest is offered and administered by Encorp Pacific (Canada) and Carton Council of Canada (collectively, the "Sponsors" and each a "Sponsor"). The Sponsors and their respective parent companies, subsidiaries, affiliates, prize suppliers, advertising/promotion agencies and any other individual or entity involved in the development, production, administration, or fulfillment of the Contest may be referred to collectively as the "Contest Parties".

#### 2. Who Can Participate?

The Contest is only open legal residents of the province of British Columbia, who have reached the age of majority at the time of entry.   character, such as OJ Carton and Joyce Box, and the recyclable beverage carton may be for juice,
  milk, or plant-based beverage; and
- share the drawing on Facebook, Instagram, or Twitter along with a message that (i) tags or mentions RecycleCartonsCA and Return-It and (ii) includes the hashtag #RecycleBeverageCartons.

When all required steps of the entry process are complete, you will automatically be eligible to earn one (1) Entry in the Contest.

The Contest is in no way sponsored, endorsed or administered by, or associated with Facebook, Instagram, or Twitter (each, a "Social Platform"). Each Social Platform is hereby completely released of all liability by each entrant in this Contest. Any questions, comments or complaints regarding the Contest must be directed to the Sponsors and not to a Social Platform. You may use one or more applicable Social Platform accounts (each, an "Account" and collectively, the "Accounts") to participate in this Contest. To be eligible to earn an entry in this Contest, your applicable Account must be set to public and not private. You are solely responsible for ensuring your applicable Account settings are set to be able to receive notification messages, monitoring your Account for such notification messages and following all instructions contained in such notification messages that may be received from the Sponsors regarding your participation in the Contest. THIS RELEASE AND INDEMNITY SHALL CONTINUE IN FORCE FOLLOWING THE TERMINATION OF THE CONTEST AND/OR AWARDING OF ANY/THE PRIZE.

By participating in the Contest, you hereby warrant and represent that any Entry Materials you submit:

- i. is/are original to you and that you have obtained all necessary rights in and to the Entry Materials for the purposes of entering such Entry Materials in the Contest;
- ii. do not violate any law, statute, ordinance or regulation;

## 5. What Are the Prizes?

There will be 20 prizes (each, a "Prize"). Each Prize consists of a CAD \$100 gift card. Each gift card is subject to the terms and conditions of the issuer. Each gift card must be accepted as awarded and is not transferable, assignable or convertible to cash. There is a limit of one (1) Prize per person.

#### 6. What Is the Prize Winner Selection Process?

On April 7, 2023 (the "**Selection Date**")<sup>1</sup> in Burnaby, British Columbia, twenty (20) eligible entrants will be selected by random draw from among all eligible Entries submitted and received in accordance with these Rules during the Contest Period and each such selected entrant will be deemed a potential Prize winner.

The odds of winning depend on the number of eligible Entries submitted and received in accordance with these Rules during the Contest Period.

Winner Notification Process. The Sponsors or their designated representative will make a minimum of one (1) attempt to contact each potential Prize winner (using the information provided at the time of entry) within one (1) business day from the Selection Date.

Winner Confirmation Process. ANYONE DEEMED BY THE SPONSORS TO BE IN VIOLATION OF THESE RULES FOR ANY REASON IS SUBJECT TO DISQUALIFICATION IN THE SOLE AND ABSOLUTE DISCRETION OF THE SPONSORS AT ANY TIME.
- **7.2.** Limitation of liability. The Released Parties will not be liable for: (i) any failure of any website during the Contest; (ii) any technical malfunction or other problems of any nature whatsoever, including, without limitation, those relating to the telephone network or lines, computer on-line systems, servers, access providers, computer equipment or software; (iii) the failure of any Entry or other information to be received, captured or recorded

for any reason whatsoever, including, but not limited to, technical problems or traffic congestion on the internet or at any website; (iv) any injury or damage to an entrant's or any other person's computer or other device related to or resulting from participating in the Contest; and/or (v) any combination of the above. Without limiting the generality of the foregoing, by participating in the Contest, each entrant releases the Released Parties from any and all liability in connection with this Contest and his/her participation therein.
